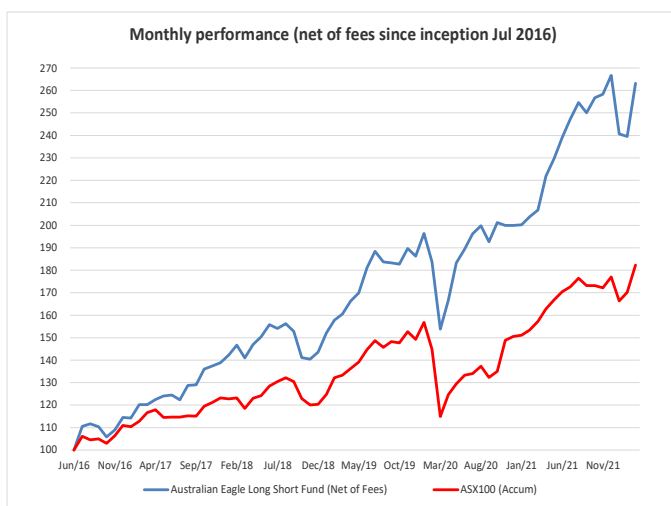

### Portfolio Overview

The Fund returned +9.88% net of fees in March 2022. The portfolio's largest positive contributions for the month came from long positions in Icitec Pivot, Commonwealth Bank and IGO while largest detractors were short positions in Block Inc, Lendlease and Washington H. Soul Pattinson and Co. The Net Asset Value of the Fund was \$95.4m as at 31<sup>st</sup> March 2022. The Fund had 30 long positions and 18 short positions with largest exposure to medical devices & services and energy transition stocks. There was relatively less exposure in consumer staples and utilities stocks.
