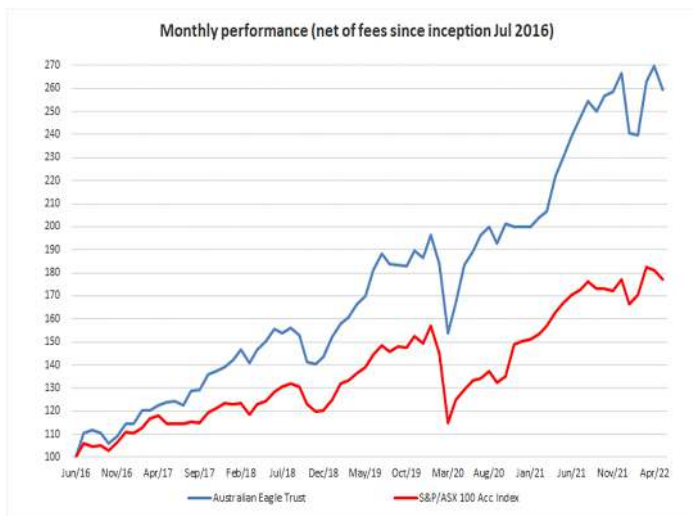

Portfolio Overview

The Fund returned -3.88% net of fees in May 2022. The portfolio's largest positive contributions for the month came from short positions in Lendlease, Block Inc and Domino's Pizza Enterprises while largest detractors were long positions in Macquarie Group, Incitec Pivot and Corporate Travel Management. The Net Asset Value of the Fund was \$93.9m as at 31st May 2022. The Fund had 29 long positions and 21 short positions with largest exposure to medical devices & services and energy transition stocks. There was relatively less exposure in consumer staples and utilities stocks.
