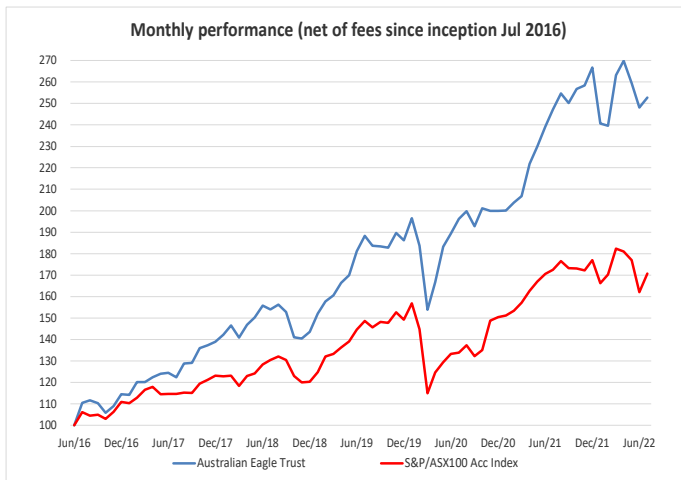

Portfolio Overview

The Fund returned +1.92% net of fees in July 2022. The portfolio's largest positive contributions for the month came from long positions in Commonwealth Bank, Macquarie Group and Incitec Pivot while largest detractors were short positions in Xero, Ansell and ARB Corporation. The Net Asset Value of the Fund was \$94.4m as at 31st July 2022. The Fund had 27 long positions and 19 short positions with largest exposure to medical devices & services and certain energy transition stocks. There was relatively less exposure in real estate and utilities stocks.
